SECTION 4: First aid measures

4.1 Description of first aid measures

General notes

Vapours are heavier than air, spread along floors and form explosive mixtures with air. Vapours may form explosive mixtures with air.

Advice on general occupational hygiene

Wash hands after use. Do not eat, drink and smoke in work areas. Remove contaminated clothing and protective equipment before entering eating areas. Never keep food or drink in the vicinity of chemicals. Never place chemicals in containers that are normally used for food or drink. Keep away from food, drink and animal feedingstuffs.

- Ventilation requirements

Keep any substance that emits harmful vapours or gases in a place that allows these to be permanently extracted. Use local and general ventilation. Ground/bond container and receiving equipment.
